### Program Details

The Newfoundland and Labrador Home Heating Rebate program provides assistance for households which incur heating costs. Regardless of the energy source purchased to heat the home, eligible households will receive a maximum rebate of \$250, where family net income for 2008 is less than \$35,000. Households in Coastal Labrador communities will receive a maximum rebate of \$500. A partial rebate is available to households with family net income for 2008 above \$35,000 but less than \$40,000, with a minimum rebate of \$100. Only one person per household may apply for the rebate. Applications should be submitted to the Provincial Department of Finance and must be received or postmarked by September 30, 2010. **An application cannot be processed without the appropriate Social Insurance Number(s) and consent.** Enquiries may be made toll-free long distance at 1-866-990-3444 or by e-mail at [homeheatprogram@gov.nl.ca](mailto:homeheatprogram@gov.nl.ca). Due to the high volume of applications expected, please allow up to 10 weeks for processing.

### Special Circumstances

A number of special circumstances mean that you may still qualify even if your family net income for 2008 exceeds \$40,000. If any of the following circumstances apply to you, **please check the appropriate box.** You will be required to provide documentation as indicated to support your claim.

**Death of a Spouse:** If your spouse was deceased as of December 31, 2009 and reported income in 2008, your eligibility will be based on your income only. Please provide your spouse's social insurance number and a copy of the death certificate.

**Long-Term Care:** If a spouse is resident of a long-term care facility, you may deduct payments to the facility supporting his or her care in determining your eligibility. Please provide documentation supporting the amount and nature of payments.

**Funded Adult Basic Education (ABE)/Skills Development:** If you received government funding in 2008 to attend an ABE program or for skills development and that funding was included on your 2008 income tax return, you may deduct this funding in determining your eligibility. Please provide documents supporting the government assistance as well as your enrollment in the course.

**Divorce/Legal Separation:** If you have divorced or legally separated as of December 31, 2009 but filed your 2008 tax return as married or common-law, your eligibility will be based on your income only. Please provide your ex-spouse's social insurance number and proof of the divorce or legal separation.

### Required Documentation

Only one invoice is required for each application. If the source of heat is furnace oil, stove oil or propane, include a copy of a heating oil invoice from September 2009 to April 2010. For other sources of heat, such as electricity, wood or wood products, please enclose a copy of the top portion of an invoice for an electricity purchase (showing the meter number and account number) from the period September 2009 to April 2010. Invoices should be in the name of the applicant or the applicant's spouse. Further documentation may be requested to process your application.

### Certification and Consent
